RESPONSIBILITIES OF OWNER:

I, _____ (print name) agree to the following:

- 1) Pay the appropriate fee at time of drop off
- 2) Pay all medical, hospital and veterinarian expenses
- 3) If the animal becomes ill or is injured, the owner shall be notified at once for instructions and if the owner cannot be contacted or does not answer the notice, the kennel owner shall have the right to use her judgment regarding measures to be taken for the welfare and health of the animal.
- 4) The kennel owner is not liable for any damage which may accrue from the boarding of the animal including but not limited to, loss by fire, theft, running away, death, injury to person, animal, or property, except if by gross negligence of the kennel owner and the liability of the kennel shall not exceed the sum of \$500.00.
- 5) The kennel owner is hereby granted a lien for any unpaid boarding and/or other cost. The owner will pay for boarding charges the day they become due and payable.
- 6) The kennel owner may exercise lien rights and 10 days after the written notice to the owner at the address above may dispose of the animal for unpaid charges. The owner waives all other legal notice. The owner shall be liable for all expenses incurred.
- 7) A dog's behavior is the responsibility of the owner. By signing this form I, (the owner) agree that I have filled all requested information in to the best of my knowledge and should I neglect to add needed information, the kennel owner is not responsible for and mishaps that could have been avoided by proper information.
- 8) It is understood that the word owner means owner of the animal and the word kennel owner means owner of the boarding kennel. No person is authorized to change or alter this agreement signed this _____ day of _____ 2013
